SUMMARY ANNUAL REPORT

For Yale University Tax-Deferred 403(b) Savings Plan

This is a summary of the annual report for Yale University Tax-Deferred 403(b) Savings Plan, EIN 06-0646973, Plan No. 004, for period January 1, 2022 through December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by insurance and a trust fund. Plan expenses were \$38,994,282. These expenses included \$246,003 in administrative expenses, \$38,725,853 in benefits paid to participants and beneficiaries, and \$22,426 in other expenses. A total of 23,538 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$785,386,382 as of December 31, 2022, compared to \$866,583,888 as of January 1, 2022. During the plan year the plan experienced a decrease in its net assets of (\$81,197,506). This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had a total loss of (\$42,036,597), including employer contributions of \$61,068, employee contributions of \$7,349,498, other contributions of \$15,297,341, losses from investments of (\$61,636,184), and other losses of (\$3,108,320). Additionally, \$166,627 of assets were transferred from this plan to the Yale University Retirement Account Plan and the Yale University Matching Retirement Plan during the plan year.
