FUNDING

\$60,000 per year (direct costs) for 3 years. (Total: \$180,000)

NOMINATION LIMITATION

Yale University may nominate one candidate.

BACKGROUND

The mission of the Mallinckrodt Foundation is to support early-stage investigators engaged in basic biomedical research that has the potential to significantly advance the understanding, diagnosis, or treatment of disease.

In preparing their proposals, faculty members should bear in mind that, although the Board selection process is shepherded by Trustees with a background in biomedical science, the goal and key features of the project should be described at a level that can be understood by lay members of the Board, who will ultimately have an important role in the final selection of award recipients.

Proposed budgets must justify how the funds to be received will be used to advance the unique problem under study in a way that cannot be done with existing funds.

ELIGIBILITY

- **Candidates should hold an MD and/or PhD degree and must be in the 1st through 4th year of a tenure-track faculty position, having started in their first tenure-track position not earlier than calendar year 2014.** At the School of Medicine, this means that candidates should be in, or heading toward, the Traditional track.
- The Mallinckrodt award is designed to move the proposed project forward to the point where R01 or other independent funding can be obtained.
- Applicants with current R01 funding as PI for the proposed or other projects should NOT apply.
