FUNDING

- Each award provides 50% salary support and benefits for a period of 3 years.
- Scholars attend twice-yearly meetings where they present their work in progress, receive feedback and mentoring from the Faculty Scholars Program Committee and other Scholars, and have the opportunity to develop collaborations with other researchers.

NOMINATION LIMITATION

Yale University may nominate two candidates.

PURPOSE

The Greenwall Faculty Scholars Program in Bioethics supports innovative bioethics research that goes beyond current work in bioethics to help resolve real-world pressing ethical issues in clinical care, biomedical research, and public policy. Career development awards enable outstanding junior faculty members to develop an original research program that addresses important innovative and emerging topics in bioethics in a rigorous and creative way and that significantly advances thinking well beyond what has already been published on the topic.

Lower priority is given applicants working on institutional change, educational reform, or primarily theoretical research.

ELIGIBILITY

- Candidates must be junior faculty members holding at least a 60% tenure-track or equivalent appointment.
- Priority is given applicants who are below the rank of (tenured) Associate Professor whose work will have an impact on public policy, biomedical research, or clinical practice; and who will make important contributions to the field of bioethics over the course of their careers.
- While the amount of an applicant's original work in bioethics will count favorably toward his/her application, outstanding candidates with less direct experience in bioethics are encouraged to apply.
- Awardees are expected to spend at least 50% of professional time annually on the proposed project.

- 2. A three-page, single-spaced document, with one-inch margins and font size no smaller than 12 point, that includes:
 - A description of the research proposal, particularly its significance
 - How the research will be carried out and how it is likely to have an impact on public policy, clinical practice, or biomedical research
 - A personal statement describing the applicant's goals in the field of bioethics
 - References/citations do not count against the three-page limit.
- 3. A CV, no more than five single-spaced pages.
