FUNDING

\$70,000 per year for a period of 5 years. (Total: \$350,000; direct costs: \$65,117 per year) Funds may be used to cover research effort of up to 50% of professional time.

NOMINATION LIMITATION

Yale may nominate one candidate from each major division of the University.

PURPOSE

Support is for promising early-career researchers in the social, behavioral, and health sciences whose studies will tackle important questions that will advance theory, policy, and practice for youth ages 5 to 25 in the United States. For the July 1, 2019 start date, applications should aim to increase our understanding of: (1) programs, policies, and practices that reduce inequality in youth outcomes, and (2) strategies to improve the use of research evidence in ways that benefit youth. The Foundation seeks research that builds stronger theory and empirical evidence in these two areas, and that such research will inform change. ELIGIBILITY

- Early career researchers in any discipline who will significantly expand their expertise in new disciplines, methods, and content areas.
- Applicants from universities must hold a tenure-track position.
- Applicants must be within 7 years of the completion date of the first MD residency or for non-MDs, within 7 years of the date the doctoral degree was conferred and, in both circumstances, have already begun a record of publication. This award cannot be used as a postdoctoral fellowship.
- Applicants must identify 1 or 2 mentors who will be committed to aiding the candidate and will contribute significantly to the Scholar's professional development during the first 2 years of the award.
- Candidates should have a promising track record, and an interest in pursuing a significant shift in their trajectory as researchers. In all cases, the candidate's research plan will significantly extend the applicant's expertise in new and significant ways. Proposed research plans must address questions of policy and practice that are relevant to the Foundation's focus areas.
